- 10.13 <u>APOLOGIES FOR ABSENCE:</u> Cllrs Lloyd, Suthers
- **10.14** DECLARATIONS OF INTEREST: There were none.
- **10.15** MINUTES OF LAST MEETING: The Minutes were accepted as accurate.
- **10.16** MATTERS ARISING:
- **10.17** <u>APPLICATIONS FOR GRANTS:</u>
- **10.17.1** Cylch Meithrin/Ti a Fi: The Committee, having reviewed the accounts, was minded to refuse a grant because of the significant surplus at the end of 2009.
- 10.18 <u>FINANCIAL STATEMENT:</u> The financial statement was presented to the committee. The net balance was £71,518.94 including £8,950.74 in the Capital Reserve (Millennium Fund) account. £730.00 remains in the grant budget.
- 10.19 <u>BANK RECONCILIATION FOR QUARTER 3</u>: The bank reconciliation for Quarter 3 was presented and accepted.
- **10.20** <u>INTERNAL AUDITOR'S REPORT 2008-09</u>: The committee noted the contents of the report and thanked the Clerk and David Barnard.
- 10.21 OCR DRAINS: The Clerk had sought the advice of T R Davies, Chartered Surveyors and been advised not to pursue the insurance claim. The Committee recommended that this advice be followed and the Community Council's claim to repair the drains be ended.
- **10.21.1** The Clerk had sent Campbell Smart of Currans a copy of the DynoRod report and awaits a response on a possible claim through the RMA's insurance.
- 10.21.2 <u>BUDGET 2010-2011:</u> Cllr Davies led a discussion of the financial figures for 2009-10 and consideration of a budget for 2010-11. Cllr Davies then proposed, and Cllr Granger seconded, that a budget of £65,000.00 with a Precept of £65,000.00 for 2010-11 be recommended to the main Council, subject to clarification of the Morganstown Village Hall grants. All agreed.
