- **09.2274** APOLOGIES FOR ABSENCE: There were none.
- **09.2275** DECLARATIONS OF INTEREST: There were none.
- **09.2276** MINUTES OF LAST MEETING: The Minutes were accepted as accurate.
- **09.2277** MATTERS ARISING: There were none.
- **09.2278** APPLICATIONS FOR GRANTS:
- **09.2278.1** A request from Urdd Gobaith Cymru was refused because it is a national group.
- **09.2278.2** Cllr Granger proposed, Cllr Silver seconded that £100.00 be granted to the British Legion to include £18.00 for a wreath for Remembrance Day 2009. All agreed.
- **O9.2279** FINANCIAL STATEMENT: The financial statement was presented to the committee. The net balance was £85,832.26 including £8,949.61 in the Capital Reserve (Millennium Fund) account. £1,920.00 remains in the grant budget.
