- **09.1967 DECLARATIONS OF INTEREST:** There were none
- **09.1968** MINUTES OF THE LAST MEETING: The Minutes were accepted as accurate.
- **09.1969** <u>MATTERS ARISING:</u>
- 09.1936.1 Carnival Project : it was agreed to ask the RMA for a report on progress to date.
- 09.1938 Council funds: After discussion, Cllr Granger proposed and Cllr Lloyd seconded that all funds remain in the Council's Business Reserve account while interest rates were so low. All agreed.
