10. Draft Budget 2023/24

To consider the draft budget 2023/24 and prepare any recommendations for Full Council.

The Clerk (RFO) must each year, by no later than December, prepare detailed estimates of all receipts and payments including the use of reserves and all sources of funding for the following financial year in the form of a budget to be considered by the Finance Committee and the Council.

The Council must consider annual budget proposals including recommendations for the use of reserves and sources of funding.

The following documents are attached:

- (i) Details of 2021/22 finances, showing year end income and expenditure.
- (ii) Details of 2022/23 budgets, showing income and expenditure to 30 September 2022 and anticipated year end outturn. This document inevitably remain work in progress.

This anticipates budgets and precept remaining at current levels for 2023/24. Members have already identified potential projects to ensure that budgets are more fully spent next year. Expenditure in recent years has been affected by Covid-19. General reserves would be used again to offset the precept

Any proposals from the committee to amend this will be incorporated into a report to Council. Potential pressures could include IT provision and OCR maintenance.

This information allows proposals for 2023/24 to be formulated.

(iii) Details of existing reserves at 31 March 2022 and forecasted outturn are attached.

Additional finance could be set aside within Earmarked Reserves to fund new projects.

11. Grant Strategy

Members have asked to review the Council's Grants Strategy. A copy of the existing grant application form is attached to allow members to begin this process and make suggestions. A revised strategy with then be reported to a future meeting.

Key issues could include publicity, evaluation, and monitoring.

12. Grant Applications

To consider the attached application from the Radyr Friends of Alzheimer's to make an application for a Choir Concert in Christchurch in January 2023. (£250). This is in aid of the work of the Alzheimer's Society. The local group has managed to raise over £50000 in the last 4 years and would like to continue to support the Society in its works towards finding a cure for the disease. The Council's support in this matter would be shown on the programme and literature.
