## FIN23/52 Update on Bank Account

The Chair has spoken with Nat West and HSBC. A further call with Barclays is due on 5<sup>th</sup> April. The details of this call and a summary will be supplied to the Finance Committee for discussion at Full Council on the 18 April.

The precept monies are now in the RMCC bank account. The two current accounts are showing very high balances at the moment. For security reasons the Chair proposed a transfer of  $\pounds120,000$  from the OCR current account and  $\pounds150,000$  from the RMCC current account to the RMCC instant

access savings. This has already been discussed with our accountant and she has no objections. The OCR board has been e-mailed for their confirmation and David Silver and Tryone Davies agreed to this transfer at the meeting. The Assistant Clerk will be notified to make these transfers in the next couple of days.
